HOW TO APPLY?

- 1. CHECK YOUR IDEA IS ELIGIBLE ON THIS POSTER, OR GIVE US A CALL
- 2. IF IT IS, YOU WILL NEED TO FIND QUOTES FOR THE WORK YOU WANT
- 3. YOU SEND US QUOTES, ACCOUNTS AND A LITTLE MORE INFORMATION
- 4. WE WILL APPLY ON YOUR BEHALF WITH PRIORITY TO SMALL SCALE COASTAL VESSELS
- 5. WAIT UP TO 8 WEEKS FOR APPROVAL, FROM THERE, YOU CAN START YOUR PROJECT

QUESTIONS & ANSWERS

WHAT IS A GRANT?

The Marine Management Organisation (MMO) has a fund to support the fishing industry. There are grants available to support your business. This is money you do not have to pay back.

HOW MUCH GRANT CAN I GET?

The money has to be spent on approved items and before you can spend it you need to make an application and get back an offer letter. The smallest project is £650 and the maximum is £150,000. Grants are from 50% to 80%.

IS IT EASY TO DO?

No, there is a fair amount of paperwork and detail needed.

DO I GET THE CASH UP FRONT?

No. You need an offer letter, then you buy the items on your offer letter, have the work done on your boat or building works or equipment or vehicle and then you claim the money back.

HOW MUCH CASH DO I GET BACK?

For safety work on your boat its 80% so if it cost £2,000 you would get back £1,600. For other work it depends on how you fish and how big your business is.

WHAT IF I DON'T HAVE ALL THE MONEY TO PAY OUT?

The Commsave Credit Union has a special fund to make loans to fishermen and fisherwomen to cover the full cost. You payback when the MMO pay your grant.



WHO CAN HELP?

You can make your own application or you can appoint an agent (such as us) to work for you.

WHAT ARE THE FISHING ANIMATEURS?

We are a team based in Newlyn in Cornwall who help fishermen and fisherwomen to understand the rules and make applications. We work anywhere in the UK and will visit your harbour, especially if you have a number of fishermen or women we can speak with.

HOW MUCH DOES IT COST TO USE THE ANIMATEURS?

Our services are free if your project is under £150,000. Our priority is the under 10m fisherman and fisherwoman. If your project is bigger it may take us longer.

HOW MANY PROJECTS HAVE THE ANIMATEURS DONE?

In this financial year we have completed over 100 applications and supported over £2million of projects. We have worked on over 650 projects in total with a 99% approval rate.

HOW CAN IT BE A FREE SERVICE?

None of our work would be possible without the financial support of The Seafarers' Charity, Trinity House and The Fishmongers' Company.

I'M NOT VERY GOOD AT PAPERWORK AND READING -CAN YOU STILL HELP?

Yes, we do all the writing, application forms, claims and just about anything we can to make it happen. We do this for both the grant and the credit union application.



CAN I USE MY LOCAL CHANDLERS OR BOAT YARD?

Yes, you need to get a quote for the work, not an estimate; we can help source comparative quotes.

DO I NEED TO BUY EXACTLY WHAT'S ON MY OFFER LETTER IF I CAN FIND IT CHEAPER OR QUICKER?

You must ONLY buy what is on your offer letter from the supplier on your offer letter. You must pay from your bank account and NEVER use cash. There must be a paper trail.

I DON'T USE A COMPUTER OR HAVE AN EMAIL ADDRESS -CAN YOU STILL HELP?

Yes, we do all the computer work for you. We can post all that's needed to you with a prepaid envelope so you can post it back.

WHO DO YOU WORK FOR?

The team work for CCDL Innovation, the trading company of the Cornwall Rural Community Charity.

MY BOAT IS NOT ON THE REGISTER CAN YOU HELP?

No, not with a grant. The boat needs to be on the register. Talk to us as we can offer some guidance.

ARE ANY GRANTS AVAILABLE FOR MY HARBOUR?

Yes, the grants cover harbours for a wide range of projects - just ask. The rate is 75% for all eligible work.

HOW DO I FIND OUT MORE?

We have a range of guidance available and are happy to answer your enquiries by phone or text. We can send out our information by post.



HOW LONG WILL IT TAKE?

It all depends on how complicated your job is and how big. If it is over £30,000 we need to write a business case. We usually submit applications within 20 working days. You will then get a go ahead at your own risk email and an offer letter usually within 8 weeks.

DO I NEED TO CONTACT THE MARITIME AND COASTGUARD AGENCY?

If you are planning any work on your boat, it is vital to make contact with the MCA and seek approval. The MMO will not start an application check until you have done this. We can help with the format for this.

HOW LONG DO I HAVE?


Applications are open now and money is available now. The programme closes in March 2025 so all projects will need to complete in January 2025 at the latest and claimed then at the very latest.

SHOULD I BE IN A RUSH?

YES. If your boat is under 12m and you want to undertake work on your boat the rules change on 6th September 2023 and what is grant aided now will NOT be grant aided after that date.

The Code of Practice for the Safety of Small Fishing Vessels of less than 15m length overall has the details. Ask and we will send you a copy in the post or email the link to you.





Also Eligible: wheelhouse windows, auto pilot, LED lighting, generator, flaker, cat catcher, ice, net or fish boxes, bad weather gear & gloves, engine cut out, solar power battery.

I'M THINKING OF SELLING DIRECT AND ADDING VALUE?

A wide range of things are grant fundable from crab boilers to fridges, website and all you need to set up a shop.

I AM PART OF A FISHING ASSOCIATION CAN YOU HELP US WITH ANYTHING?

Yes we work with a wide range of partners and can help with a wide range of projects from new sheds to direct selling or help with setting up a new association, give us a call.

CAN YOU DO ANYTHING FOR MY HARBOUR?

We can support a wide range of smaller projects from ice machines and bait stores, davits and cranes to winches, low level light and CCTV. The grant rate is up to 75% we have harbours happy to share their experience.

DO YOU KNOW ANY SCIENTISTS WHO COULD HELP WITH AN IDEA I HAVE?

The animateurs work closely with the Fishmongers' Company who support science projects from fishermen and fisherwomen with a network of universities. If an idea is taken further it can be 100% funded and the research undertaken.

Commsave is a Credit Union that offers safe savings and low-cost loans facilities. Their services are available to anyone working in the UK fishing industry – whether you are a fisher; working in fish processing; of if you're a fishmonger.

ENGINES

CAN I GET A GRANT FOR A NEW ENGINE?

Yes. It's a complicated area with grants available for electric, hybrid and diesel or petrol. We can email or post you the full guidance. Your boat must be under 11.99 metres and fished selling its catch for 60 days over the last 2 years. With a valid licence and on the register.

I WANT TO REPLACE MY OLD DIESEL OR OUTBOARDS

You can apply for 50% of the costs including fitting and any modifications needed up to a maximum of £40,000 grant towards a £80,000 project. If you have two engines already grant aid is available on both

HOW OLD DOES MY ENGINE HAVE TO BE TO BE ELIGIBLE?

Engines constructed before 2016 can be replaced for a like for like, new model with the same or less power.

HOW BIG CAN MY ENGINE BE?

An engine power matching or below the power stated on your license will be eligible. The replacement engine can not be any more powerful than your current engine.

WHAT HAPPENS TO MY OLD ENGINE?

You can do as you wish, keep as a spare, sell it or scrap it.





DO I NEED TO CONTACT THE MCA BEFORE I START?

Yes, you will need a business plan and quotes before you seek approval from the MCA. The MCA require a non-grant eligible payment up too £882 to carry out a survey once the work is completed.

DO I NEED A QUOTE FOR THE NEW ENGINE?

Yes, you will need 2 quotes if your engine is under £5,000 or 3 quotes if over £5,000. It needs to be a detailed quote from an authorised dealer with the associated confirmation statements. If you get the quote you want we can help with the other quotes.

DO I NEED RECORDS?

Alongside your fishing records you will need to record before the grant your fuel usage in litres per month, distance covered per month, landings data and turnover. Once the new engine is fitted you will need to record these for 12 months and do an on line survey.

CAN THE ANIMATEURS HELP?

Yes we can support you, please email call or text for our application pack.
